In case you missed it...North Kansas City experienced an astounding number of businessrelated events in 2022. The outlook for 2023 is just as fascinating. Here is a look back and a look forward.

Last Half of 2022

Approximately three million

square feet of North Kansas City buildings on 156 acres owned by Northtown Devco was sold to ATCAP Partners, an investment group from Dallas, including a variety of commercial, industrial, office and retail properties.

NT Realty was replaced by Cedar Ridge Property Management to manage the ATCAP properties.

As a way of expressing their commitment to North Kansas City, ATCAP and Cedar Ridge set up a huge Christmas tree at the SE corner of Armour and Swift. They also put Christmas lights on their retail buildings along Armour.

Oracle Cerner vacated their former multi-building, hilltop, Cerner HQ campus at the end of

November with only one-month notice. As of this date the property is for sale.

A Holiday BucketList of 66 North Kansas City destinations and attractions was compiled, published and distributed by the North Kansas City Business Council – online as well as on a printed hardcopy trifold.

The downtown streetscape project by the City was completed, exhibiting a significant improvement with new brick sidewalks and new trees.

The final phase of the Armour Road Complete Streets project and repaving of Armour by the City was completed.

Forty-one businesses sponsored Christmas trees on new streetlight poles in the downtown district.

The 250 space City parking lot between 16th Ave and 18th Ave was completed.

Global Entrepreneurship Week-KC chose iWerx as "Base Camp" for hundreds of visitors for entrepreneur-focused presentations November 14-20.

Gallery Lofts Apartments was completed and completely sold out before opening.

A second large Exltube steel tube manufacturing building was put into service in a large new building at W 10th Ave and Atlantic.

Exltube was sold by SPS Companies to Zekelman Industries, the largest steel pipe manufacturer and distributor in the U.S.

Construction of The Oxbow apartment building was completed – including an attractive brick façade covering the whole building. A temporary leasing office was set up at the corner of Erie and E 18th Ave.

Wolcano Teppanyaki, ReWind Video & Dive, District Biskuits and F325 BBQ opened.

The 100% interior refurbishment of Life Unlimited building at 320 Armour was completed, including an attractive rooftop event space.

Calibration Brewing and Smokin' Guns BBQ closed.

Construction was completed on the \$15 million water treatment plant renewal project.

The re-construction and upgrade of the baseball field at Macken Park was completed, providing a great home field for the North Kansas City High School Hornets as well as a tournament venue.

- Construction beginning on the Genesis Fitness
   Center with 16 sand volleyball courts
   and a restaurant in One North
  - Construction beginning on the grocery store in One North
- Construction beginning on the *Blume NKC* vertical mixed-use townhomes in Northgate Village
- Completion of the final phase of Northgate Village row homes by Hunt Midwest and Aspen Homes
  - Construction beginning on the 310,000 sq. ft. Tnemec Company's new building which will be visible behind the carwash on Burlington
  - Beginning of major refurbishment and adaptive re-use of the large NOCIX/KC Fiber building on Swift between 14th and 16th
    - Progress on the Burlington Road Complete Streets project
  - Progress on a decision about streetcar extension into North Kansas City
  - Progress on a new park in the River Forest residential area near North Kansas City Hospital

#### Big Questions/Unknowns at this Time

What types of development/re-development will ATCAP Partners, the new owners of three million square feet of North Kansas City buildings, undertake?

Will there be further announcements about new restaurants or other attractions in One North?

What's next for: the former Oracle Cerner campus; the former bowling alley property; the former Smokin' Guns BBQ building; the former Calibration Brewing building; the former Denim & Diamonds building; the vacant lot on the southwest corner of Armour and Swift and the former QT location on Armour?

Will a creative solution arise for a better use of the

area behind Chappell's known as Town Square?

Will there be streetscaping improvements for north and south streets near downtown (Buchanan, Clay, Erie, Fayette and Howell) to complement the work on Armour and Swift?

When will the City start demolition of the condemned silo structures between the railroad tracks paralleling Bedford in the Paseo Industrial District? And how will they do it with railroad tracks next to it on both sides?

Will there be any new faces on the City Council after six of eight of those positions are on the April ballot? Four are in the normal cycle; two are because of appointments by the Mayor to finish the year due to resignations from the City Council.

#### **NORTH KANSAS CITY BUSINESS COUNCIL AWARDS**

The North Kansas City Business Council annually presents four awards at The Big Event Holiday Reception & Auction. Here are the awards presented December 1 at Harrah's.

#### Spirit of Giving Award— Chicken N Pickle

Chicken N Pickle has become famous for a lot of things, including being a fun place to have lunch or to play pickleball or any of the yard games. Their rooftop bar is a big attraction. They are always complimented for their great food as well. And they seem to be making news every week announcing new locations across the country. We are proud to have the original location and the corporate headquarters here in North Kansas City.

One of the things Chicken N Pickle is most proud of is their intentional effort to support non-profits and charities. Every one of their locations stresses the theme, "Our Hearts are Local." To do that they partner with local organizations for charitable events and with local vendors when possible. They also make charitable donations and they host fundraisers. They do this through their Chicken N Pickle Foundation and occasionally have special days when 10% of the purchases goes to the foundation.

#### Workforce Development Award— Tnemec Company
